Important Instructions

1. The State Government/ UT/ Directorate of Technical Education/ Directorate of Medical Education shall ensure that 10% of reservation for Economically Weaker Section (EWS) as per the reservation policy for admission, operational from the Academic year 2020-21 is implemented without affecting the reservation percentages of SC/ ST/ OBC/ General. However, this would not be applicable in the case of Minority Institutions referred to the Clause (1) of Article 30 of Constitution of India. Such Institution shall be permitted to increase in annual permitted strength over a maximum period of two years beginning with the Academic Year 2020-21
2. The Institution offering courses earlier in the Regular Shift, First Shift, Second Shift/Part Time now amalgamated as total intake shall have to fulfil all facilities such as Infrastructure, Faculty and other requirements as per the norms specified in the Approval Process Handbook 2020-21 for the Total Approved Intake. Further, the Institutions Deemed to be Universities/ Institutions having Accreditation/ Autonomy status shall have to maintain the Faculty: Student ratio as specified in the Approval Process Handbook. All such Institutions/ Universities shall have to create the necessary Faculty, Infrastructure and other facilities WITHIN 2 YEARS to fulfil the norms based on the Affidavit submitted to AICTE.
3. In case of any differences in content in this Computer generated Extension of Approval Letter, the content/information as approved by the Executive Council / General Council as available on the record of AICTE shall be final and binding.
4. Strict compliance of Anti-Ragging Regulation: - Approval is subject to strict compliance of provisions made in AICTE Regulation notified vide F. No. 373/Legal/AICTE/2009 dated July 1, 2009 for Prevention and Prohibition of Ragging in Technical Institutions. In case Institution fails to take adequate steps to Prevent Ragging or fails to act in accordance with AICTE Regulation or fails to punish perpetrators or incidents of Ragging, it will be liable to take any action as defined under clause 9(4) of the said Regulation.

The EOAA for Three years has been granted to the institute on the basis of the awarded Quality Index Value (QIV) of 482. The EOAA provided provisionally shall be continue on the fulfillment of the following mandatory conditions abiding to the institute.

S.NO.	Mandatory Conditions abiding to the Institute
1	Affiliated institute shall follow and fulfill all mandatory requirements as per prevailing AICTE/COA/Government (Central/State)/ Bikaner Technical University, Bikaner Act/ Statutes/ Affiliation Regulations to provide/maintain quality education.
2	Affiliated institutes shall follow all the instructions issued from time to time by the university and to furnish all the information and statistics desired by the University,
3	Affiliated institute shall not be indulged in any such activity which directly or indirectly favors illegal commercialization of education.
4	As being a registered Society/Trust, the periodical elections for various posts enunciated in the constitution therein must be ensured with transparency and its proceedings shall be sent to university.
5	In accordance with provisions under section-5, subsection (vii & ix) of Bikaner Technical University, Bikaner, Act no. 29 of 2017, University representative shall be nominated in its governing body. Proceedings of all such meetings should be held in his presence.

The awarded Three years of EOAA shall be valid subject to the following conditions:

1. The institute has to submit affiliation form and prescribed fee (Affiliation and inspection fee) every year as per university's affiliation regulation and affiliation fee rule.
2. Institute shall maintain its QIV $\geq 400 \geq 599$ throughout the 3 years of EOAA.

3. University shall revise the period of EOAA to 3 years /year wise as per the verification of QIV on the basis of the affiliation details submitted by the institute from the respective academic session. University may carry out the inspection, as per the requirement, for the verification of QIV.
4. One time EOAA granted to the institute shall be revised /withdrawn on the verification of the non-fulfillment of any mandatory requirements as laid down by AICTE/COA/BTU. The same will also applicable on the verification of any serious complaint against the institute,
5. The EOAA shall be amended as per the approved course(s), with their intakes, for the engineering program as per the Extension of Approval (EOA) of AICTE for the respective academic session.
6. The EOAA will be immediately withdrawn on the closure of engineering program/institute by AICTE and also on the non-submission of AICTE extension of Approval (EOA) before the expiry of the granted one time EOAA.
